I refer to the above referenced maritime usage licence application received by the Maritime Area Regulatory Authority (MARA) on 01/11/2024

Further to our request on 28/08/2025, MARA requires additional information as set out below in order to determine the licence application.

The GIS files submitted have an 'Area A, B, C. D, E, F, G, H, I, J and K' drawn, which correspond directly to the following Map Titles: "Licence Map Area A TO E REF: MUL240026" and "Licence Map Area F TO K REF: MUL240026" submitted which depict proposed locations along the southeast coast of Ireland to undertake strategic modelling studies of water currents and bathymetry.


- Revise maps to ensure that the GIS shapefile represents the multiple areas included in the
  footprint of the maritime area that the usage will occupy below the High Water Mark as
  defined by the Chief Boundary Surveyor with correct individual proposed area
  calculations:
  - a. For MUL applications with multiple areas a single shapefile with an attributed polygon for each area to be submitted, named sequentially, A, B, C, D etc.
    - i. Do not include additional polygon areas, see images 1-2 below:





Image 2 – Area C – Additional polygons

Image 3 – Area D




Image 4 – Area G





Image 5 – Area G
