Reason and associated Condition	Applicant comment: "We would like to request clarification and propose potential refinements to ensure the conditions are both environmentally effective and allow us to obtain the necessary data for the EIAR.			



Condition: "Works not to take place in 'Area D' between 30th April and 1st August to prevent disturbance to nesting birds." Clarification Requested: Could you confirm whether this restriction applies to all survey activities, including offshore surveys that are unlikely to cause disturbance to nesting birds within Area D? Is the restriction intended to apply to all of Area D, or would it be possible to refine the spatial extent to focus on specific sensitive locations within Area D where nesting activity has been confirmed or is most likely?" ARD recommendation: It is noted that the applicant sought two clarifications on Specific Condition 26 only, rather than providing supplementary material relating to the reasons for the condition in accordance with Section 119(6)(b)(ii) of the Maritime Area Planning Act 2021, as amended. 1. In relation to the first query, in part (ii) of Specific Condition 26, the Permitted Maritime Usage applies to all of the surveys which were applied for under application. The survey activities applied for include coastal intertidal and subtidal surveys only. 2. In relation to the second query, the restriction applies to all of Area D. The applicant has not submitted any relevant material in this submission pertaining to the reason for the condition and thus MARA cannot consider any changes to the spatial extent of the restriction to specific sensitive locations within Area D.
