I refer to the above referenced maritime usage licence application received by the Maritime Area Regulatory Authority (MARA).

Further to our request on 04/09/2025, MARA requires additional information as set out below in order to determine the licence application:

The GIS files submitted have an 'Area A, B, C, D, E, F, G, H, I, J and K' drawn, which correspond directly to the following Map Title: **"MARITIME USAGE LICENCE OVERALL PROPOSED MUL AREA MAP" Revision: P03** submitted which depict proposed locations along the southeast coast of Ireland to undertake strategic modelling studies of water currents and bathymetry.

1. Revise maps and GIS data to ensure that the GIS shapefile represents the multiple areas included in the footprint of the maritime area that the usage will occupy below the High Water Mark as defined by the Chief Boundary Surveyor:
 - a. For MUL applications with multiple areas a single shapefile with an attributed polygon for each area to be submitted, named sequentially, A, B, C, D etc.
 - i. Do not include multipart polygons, each MUL area must represent as an individual polygon area, see image 1 below:

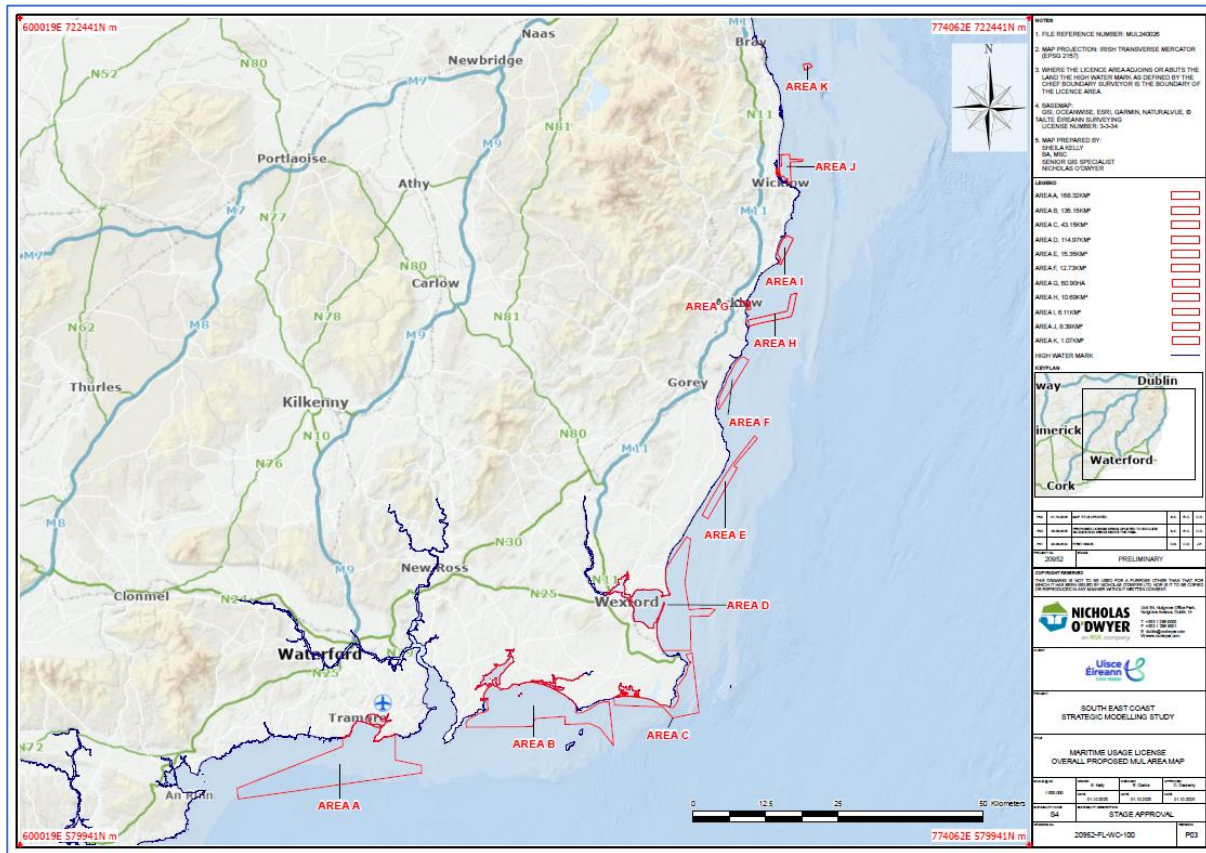

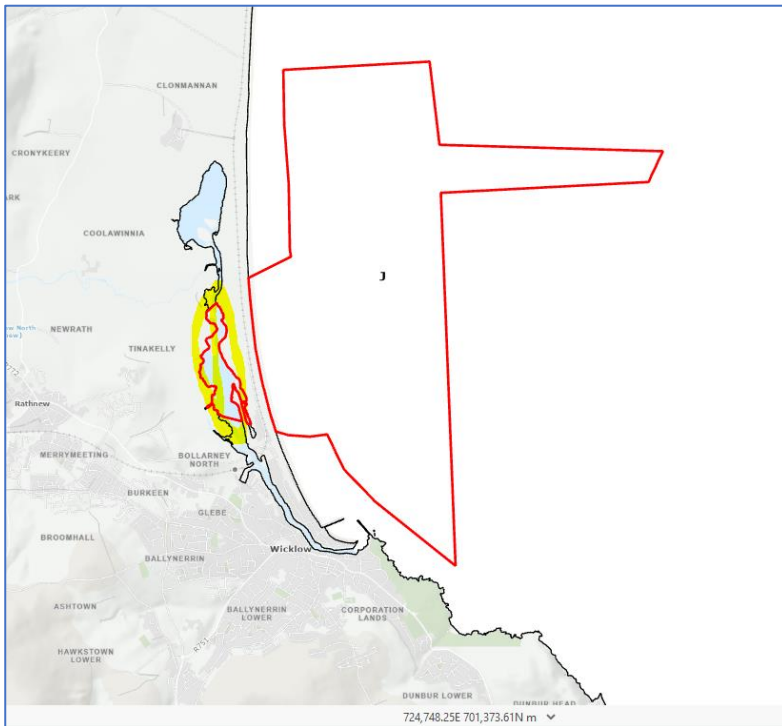
