Please see below requestion additional information/clarification as per your letter dated 4th February 2026 on the maritime usage(s) mentioned in the submitted MUL Application form.

Q: • Clarify whether the overall purpose of the application is marine environmental surveys for the purposes of site investigation (i.e. Schedule 7(3) of the Maritime Area Planning Act 2021)?

A: Yes, marine environmental surveys for the purposes of site investigation is the overall purpose of the application, as detailed in section 2.3 of the application form.

Q: • Clarify what the Schedule 7(7) usage on the Application Form is intended to apply to and whether that usage is a separate usage to the site investigation activities?

A: This is solely intended to apply to vehicle/vessels used for the purpose of marine environmental surveys as detailed in section 2.3 only; all activities are ancillary to the surveys detailed there.

I trust this will clarify the intended usage and allow the licence application to proceed to determination.
