**Notice under Regulation 37(2) of the EPA (Industrial Emissions) (Licensing) Regulations, 2013.**

The EPA granted a revised licence, subject to conditions, on 07/05/26, to Merck Millipore Limited for an installation located at Tullagreen, Carrigtwohill, County Cork. Reg. No. P0571-06, for Classes 12.2.1 the surface treatment of substances, objects or products using organic solvents, in particular for dressing, printing, coating, degreasing, water proofing, sizing, painting, cleaning or impregnating, with a consumption capacity of more than 150kg per hour or more than 200 tonnes per year and Class 11.2 (e). Disposal or recovery of hazardous waste with a capacity exceeding 10 tonnes per day involving solvent reclamation or regeneration for a facility located at Tullagreen, Carrigtwohill, County Cork. A person shall not question the validity of the decision of the Agency other than by way of an application for Judicial Review and any such application or any other legal proceedings must, in accordance with Section 87(10) of the EPA Act 1992 as amended, be instituted within the period of eight weeks beginning on the date of the giving of the decision. **Invitation for Public Submissions on an Application for a Maritime Usage Licence and an Appropriate Assessment**

Pursuant to the provision of Section 75 of the Roads Act, 1993, notice is hereby given that The Pouladuff Road, will be closed to public traffic from its junction with the Toghther Road to its junction with Forge Hill, from 0900hrs on Wednesday May 27th 2026 until 1800hrs Saturday 30th May 2026 to facilitate Road build up works.
