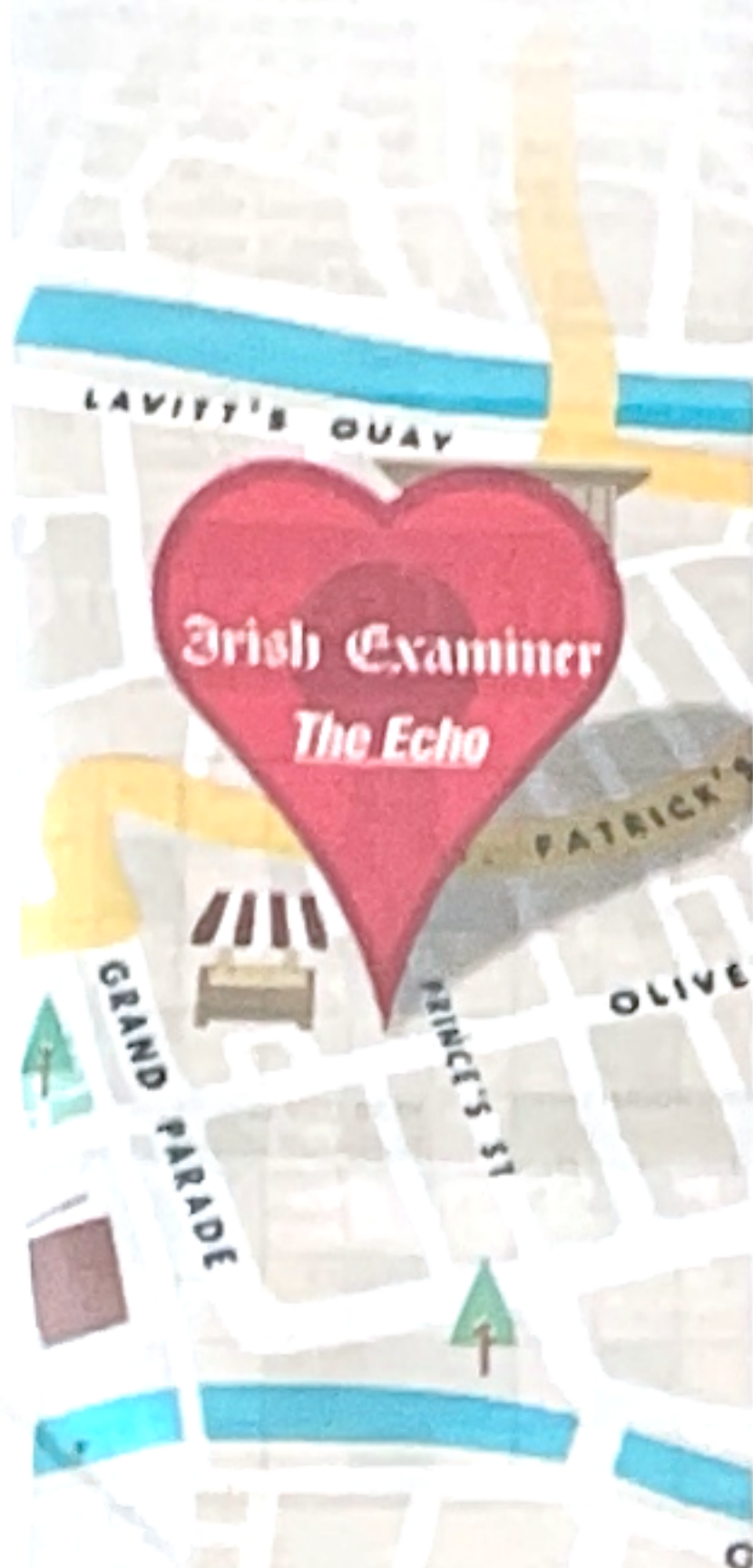

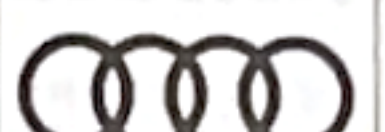

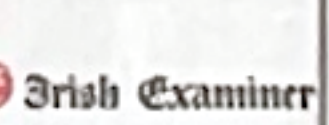

Invitation for public submissions on an application for a maritime usage licence and an appropriate assessment

Port of Waterford Company submitted an application to the Maritime Area Regulatory Authority (MARA) for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 for dredging to be undertaken in 16 areas within the Middle Suir Estuary, Lower Suir Estuary, Barrow-Suir-Nore Estuary and Waterford Harbour. These areas range from the upper end of the harbour in Waterford City right out to the seaward end of the harbour off Duncannon, Co. Wexford. The licence application is for a period of 8 years.



A related Natura Impact Statement has been submitted with the above licence application. 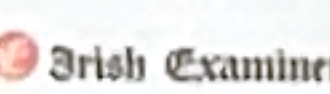
