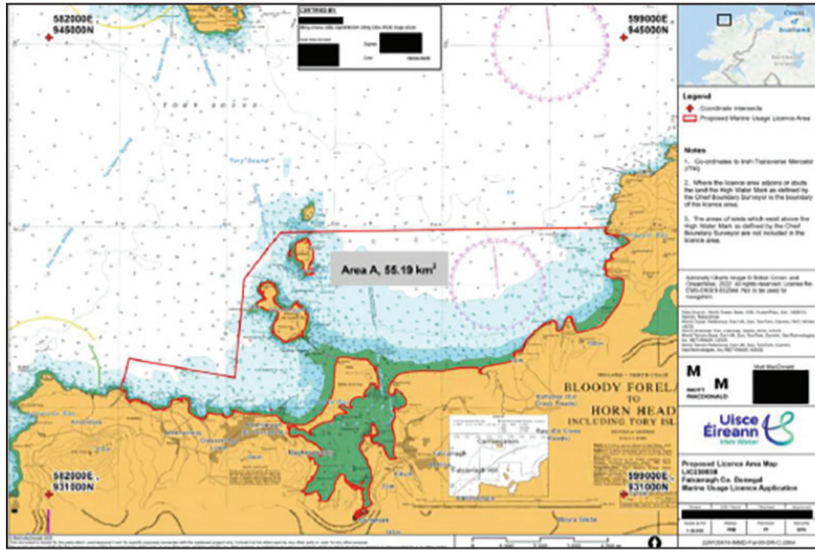


PUBLIC NOTICE

**The Maritime Area Planning Act 2021 and the European Communities (Birds and Natural Habitats) Regulations 2011
Invitation for public submissions on an application for a maritime usage licence and an appropriate assessment**

Uisce Éireann submitted an application to the Maritime Area Regulatory Authority ("MARA") for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 to undertake marine environmental surveys for the purposes of site investigation required to inform water quality models supporting Uisce Éireann's capital delivery programme to improve wastewater treatment. These surveys will inform the outfall discharge location for a proposed upgrade to Falcarragh Water Treatment Plant (WWTP), Co. Donegal in the maritime area. The licence application is for a period of 5 years.



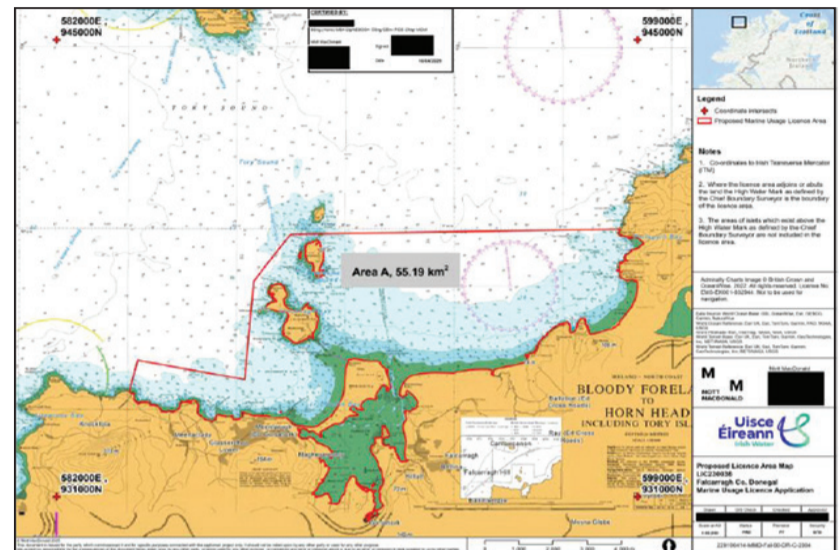

After the determination, MARA will either grant, part grant or refuse the licence application.
