Request for additional information in accordance with section 117(3) of the Maritime Area Planning Act 2021 in respect of licence application reference number LIC230025

Dear Mr. Moriarty,

I refer to the above licence application received by the Maritime Area Regulatory Authority (MARA) on 08/03/2024. MARA considers that it requires the additional information as set out below in order to determine the licence application.

The GIS files submitted have multiple areas drawn, '**DA-10**' and '**DA-13**', which correspond directly to the Map Titles: "**Licence Map 4 – Upper Channel Dredge Area**" and "**Licence Map 5 – Passage East Dredge Areas**" respectively which depict the Cheekpoint Harbour Access at Cheekpoint and Passage East Boathouse Quay at Passage East, Co. Waterford (Drawing number: 636\_MUL\_Application\_04 and 636\_MUL\_Application\_05).

1. Revise the map for **Map 4 and Map 5** to ensure that the GIS shapefile represents the footprint of the maritime area that the development will occupy below the High Water Mark as defined by the Chief Boundary Surveyor.
2. Ensure GIS shapefile format adheres to MARA requirements, i.e. Polygon format, not Polyline format
3. Ensure GIS shapefile attribution adheres to MARA requirements:
  - a. Attribute Field: "File\_R\_N" e.g. MUL##### as assigned by MARA.
  - b. Attribute Field: "Site\_R\_N" e.g. A, B, C etc.
4. Please ensure all documentation, diagrams, cartographic maps and GIS data files are updated accordingly and resubmitted to MARA.

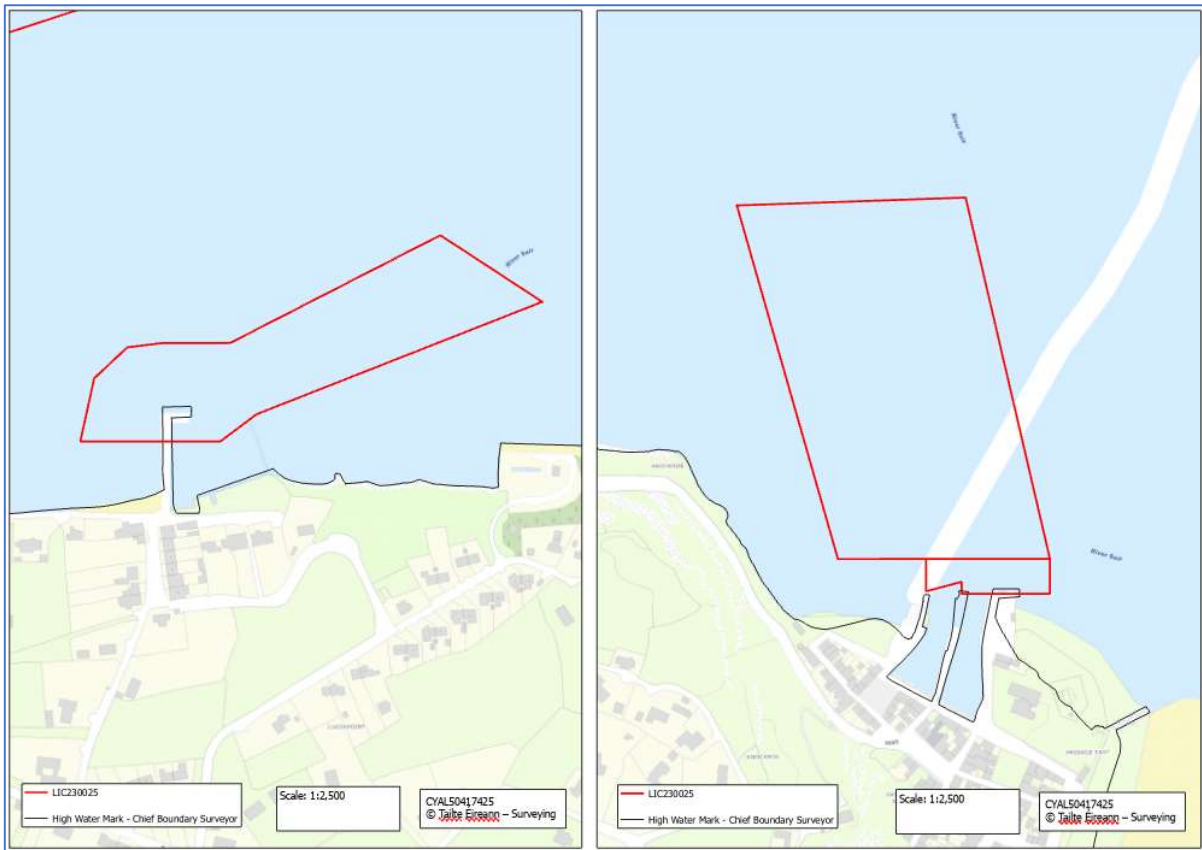
