Re Application for a Dumping at Sea Permit to facilitate dredging the Approach to Kilrush Marina.

Dear Sir, Madame,

Kilrush Maritime Ltd are hereby applying for a DaS Permit to enable the maintenance dredging of the approach channel to Kilrush Marina. This is an ongoing requirement to enable vessel access at low tide and has been carried out routinely over the last 35 years.

This company is operating the marina on a purely commercial basis, receiving no support from the state or any commercial shipping income. The marina is a significant economic generator for the West Clare area, approximately 24 people are employed full time either by the Marina or by other marine based businesses operating from the marina facilities. Further seasonal jobs are generated in the Summer months and the marina is a high profile element of the local tourism offering.

The marina services the Scattery Island National Heritage Site operated by the OPW, and provides berthage to the Irish Naval Reserve, and an Irish Customs patrol boat. Furthermore, it provides an emergency haven to both the Kilrush inshore RNLI vessel, and the Shannon Foynes Port Company's Pilot Boat, both of which are essential 24/7, 365 services.

The timely maintenance dredging of the approach channel is critical to the provision of all-tide access to the Marina, and we include letters of support from both the RNLI and SFPC to that effect.

Alongside the comprehensive environmental, social and economic considerations that accompany this application, a Maritime Usage Licence (MUL) is also being applied for in accordance with the requirements of the Maritime Area Planning Act 2021, ensuring that the proposed dredging activity and associated marine operations are fully aligned with, and compliant with, both regulatory frameworks.

We hope that this application can be processed expediously and look forward to further communication from you.

Pilotage Service Operations - Kilrush Marina support

Shannon Foynes Port Company (SFPC) is the Port Authority for the Shannon Estuary.

One of the key services provided by SFPC in support of shipping on the Estuary is the pilot boat service. This service operates on a 365/24/7 basis and is critical to operations on the Estuary.

The pilot boat operates from Cappa, Kilrush, Co. Clare.

Kilrush Marina is an important support to the provision of this service.

During periods of heavy weather, the boat very frequently operates from the Marina. Safe access during all states of tide is critical to the continued safe provision of this service.

Equally, Kilrush Marina provides an immediate ability to lift-out and inspect the boat at short notice in the event of any incident/issue. Again, safe and continuous access to the Marina is critical.
