**Request for Additional Information: Section 117(3) of the Maritime Area Planning Act 2021**

**Maritime Usage Licence Application Reference: MUL260036**

Dear Applicant,

I refer to the above referenced maritime usage licence application received by the Maritime Area Regulatory Authority (MARA).

MARA considers that it requires additional information as set out below in order to determine the licence application.

1. Clarify the number of Common Tern breeding pontoons within or in the vicinity of the MUL application area?
2. Provide the locations of all of the Common Tern breeding pontoons on a map in relation to the MUL application area. Include the MUL application area for MUL250024 on the map.
3. Clarify how the Port Company will mitigate against noise disturbance on breeding Common Tern as a result of the proposed maritime usage?
