Re: Request regarding Foreshore Licence dated 20 December 2010 between The Minister for the Environment Heritage and Local Government of the one part -and- Eirgrid Interconnector Limited and Eirgrid PLC of the second part

Dear Holder,

We refer to your request dated 16 May 2024 seeking to extend the commercial use of Foreshore Licence FS004527 dated the 20th of December 2010 and made between The Minister for the Environment Heritage & Local Government of the one part and Eirgrid Interconnector Ltd and Eirgrid plc of the other part (the Licensee).

Since its establishment date of 17 July 2023, MARA has assumed administrative responsibility for foreshore authorisations, as provided for under section 43(1)(i) of the Maritime Area Planning Act, 2021 (as amended) ("the MAP Act").

In light of your request in relation to the extension to the previous consent granted for commercial use of the Licence, MARA in exercise of its administrative responsibility over Foreshore Authorisation number FS004527 and in exercise of its statutory functions hereby consents to your request in respect of the extension to the commercial use of the Licence.

This consent will necessitate you, the Holder, executing a supplemental deed in compliance with the conditions of Licence FS004527.

Please note however that this consent is limited to the request made in your correspondence of 16 May 2024 and is not to be construed as any amendment alteration or extension of or to the terms of the licence.


